# **Lions of Illinois Endowment Fund 100% SUSTAINING SUPPORTER CLUB APPLICATION**

### What is the 100% Sustaining Supporter program?

The 100% Sustaining Supporter Club program is a method of giving in which a club can recognize a club member with a donation on an annual basis to help support the many programs and services of the Lions of Illinois Foundation. With the annual contribution of \$25 (less than 7¢ per day) through the Sustaining Supporter Campaign, a club is able to demonstrate a commitment to the Lions of Illinois Foundation and to its vision of creating a permanent vehicle for the delivery of programs and services to the visually and hearing impaired.

### How does a club become a 100% Sustaining Supporter club?

When a club donates \$25/member to the Lions of Illinois Endowment Fund. The club member will then be recognized as a 100% Sustaining Supporter Club, and each club member will be recognized as a Sustaining Supporter.

### What do the Club and Member receive?

For an initial donation, a club will receive a patch and chevron for their banner. Each year following, a club will receive a chevron for their banner for the year they made the donation.

A club member will receive a pin for the initial donation and for each following donation, the member will receive a tab every five years to be attached to their pin.

### How are the funds used?

Contributions are pooled and invested in the Lions of Illinois Endowment Fund – a restricted fund of which the principal remains intact. Only the income from the Endowment Fund can be used to support Lions of Illinois Foundation programs and services for the visually and hearing impaired. The Endowment Fund provides contributors with an opportunity to give a gift that keeps on giving.

### Are contributions tax-deductible?

Yes! Contributions to the Endowment Fund are tax-deductible to the extent allowed by law.

### Can Sustaining Supporter contributions be applied toward a Foundation Fellow?

Yes! Sustaining Supporter contributions are completely convertible to Foundation Fellows. For more information, contact the Lions of Illinois Endowment Fund at 815-754-0090.
