

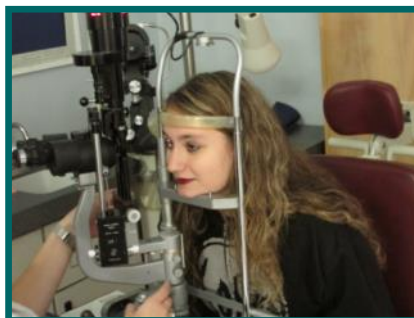

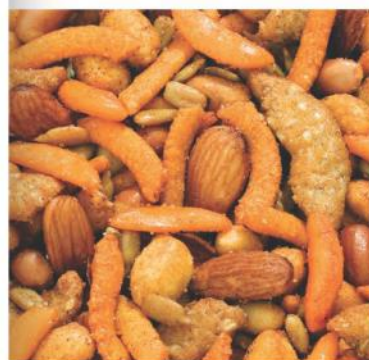
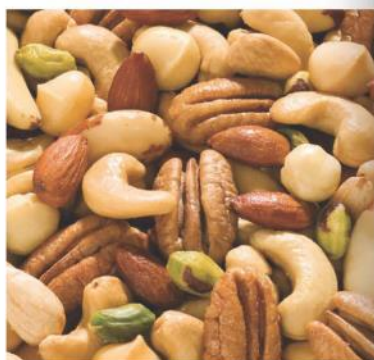

NEWSLETTER Spring 2020

Greetings Lions,

This newsletter is to give you information and updates in all of the areas that encompass The Lions of Illinois Endowment Trust and how those funds are contributed. Please go to our website www.LionsOfIllinoisFoundation.org to obtain brochures and forms pertaining to each Endowment program listed below. Contributions to the Endowment Trust are tax-deductible to the extent allowed by law.

What is The Endowment Trust? The Lions of Illinois Endowment Trust offers the opportunity for members of the Lions family and the general public to give a tax-deductible gift that keeps on giving. It is a restricted fund in which contributions are pooled and invested, with the principal remaining intact. Only the income can be used to support Lions of Illinois Foundation programs and services for people with vision and hearing needs.

Endowment Trust Mission Statement: *The Lions of Illinois Endowment Trust exists for the sole purpose of creating a consistent and permanent stream of revenue to fund the programs and services provided by the Lions for the visually and hearing impaired. It is recognized that future unmet human needs may need to be addressed and the Lions may not be able to affect those needs directly. Therefore, the Lions of Illinois through this Trust are creating a present day capability for those future needs.*

Merrill Lynch: For the past 20 years with the help and support of the management team at Merrill Lynch, your Endowment Trust has been steady at \$11.2 million dollars as of 5-19-2020. Your Foundation only takes 3% of the earned income towards the programs and services of your Lions of Illinois Foundation, 97% of the earned income is rolled back into the fund for future needs.

Foundation Fellows : A Foundation Fellow is the greatest level of recognition that can be bestowed by the Lions of Illinois Foundation and can honor anyone (Lion or non-Lion). It can be presented to a person who donates \$500 to the Lions of Illinois Endowment Trust, or it can be used as a way for others to honor a person's dedication to the club, community, Lions District, Lions of Illinois Foundation, and/or Lionism in general.

The Foundation Fellow is a means of showing commitment to the Lions of Illinois Foundation and to its vision of creating a permanent vehicle for the delivery of programs and services to people with vision and hearing needs. It is a tangible evidence of dedication to establishing a lasting legacy. For those who wish to contribute more than the \$500 or to begin a program of giving, there are 25 levels of the Foundation Fellow, with each level attained affording honor to the individual named.

How does someone become a Foundation Fellow? To become an "initial" Foundation Fellow, contribute \$500 (in partial payments or in one payment) to the Lions of Illinois Foundation, Endowment Trust. Subsequent "progressive" Foundation Fellows are \$500 each.

How are Funds Used? Contributions are pooled and invested in the Lions of Illinois Endowment Trust-a restricted fund of which the principal remains intact. Only the income from the Endowment Trust can be used to support the Lions of Illinois Foundation programs and services for people with vision and hearing needs. The Endowment Trust provides contributors with an opportunity to give a gift that keeps on giving.

Legacy Club: The Legacy Club is a way of recognizing individuals who wish to assist in the establishment of a lasting legacy to help children and adults with vision and hearing needs. Membership in the Legacy Club is granted to any person (Lion or non-Lion) who demonstrates a commitment to the vision of the Lions of Illinois Foundation by:

- leaving a bequest of any size (large or small), or
- assigning any part of a pension/retirement fund, IRA, insurance policy, or investment account

Wills, Bequests, Trusts: Individuals may choose to give an estate tax deductible gift by naming the Lions of Illinois Endowment Trust or Lions of Illinois Foundation as (1) a beneficiary of part of an estate; or (2) an assignee of part of a pension/retirement fund, IRA, insurance policy, or investment account. Individuals who provide appropriate documentation to the Lions of Illinois Endowment Trust become members of the **Legacy Club. Contributions through wills, bequests and trusts are estate tax-deductible to the extent allowed by law.**

What do I receive as a Legacy Club member? As a Legacy Club member, you receive a beautiful pin and the satisfaction of knowing that, because of you, future generations of children and adults in Illinois will receive the precious gift of hope.

Memorials: Donations may be given in the name of someone who has passed on.

Honorariums: Donations may be given to honor a special occasion such as a birthday, anniversary, graduation, promotion, retirement, becoming a Foundation Fellow, etc. or to wish someone well.

Tree of Service: The Lions are a symbol of hope, courage and integrity. Through their Clubs and affiliated philanthropies, the Lions have created a better and more independent life for the blind and deaf in Illinois. The Tree of Service stands for various service programs. The branches are symbolic of how Lions Clubs reach out into the community through their services. The Leaves are symbolic of the communities in Illinois, and the trunk of the tree is symbolic of the programs and services the Lions and Lioness of Illinois support through the Lions of Illinois Foundation.

How your Gift Grows: The contributions for the Tree of Service are deposited into the Lions of Illinois Endowment Trust. This account will continue to grow like the tree it represents. Only the interest from the donation is used to help support the programs and services of the Lions of Illinois Foundation.

The Tree of service is located in the main room of your Lions of Illinois Foundation Office.

The inscription you choose can honor or memorialize another person or event, or it can simply reflect that you gave a gift.

- ◆ **Leaf** \$1,000.00
- ◆ **Cluster of Leaves** \$3,000.00
- ◆ **Rocks**
 - ✓ **Contributor** \$5,000 through \$25,000
 - ✓ **Benefactor** Over \$25,001 through \$75,000
 - ✓ **Patron** Over \$75,001 through \$150,000
 - ✓ **Sponsor** Over \$150,001 through 300,000



What is a Sustaining Supporter? The Sustaining Supporter program is a method of giving in which anyone (Lion or non-Lion) is encouraged to give a tax-deductible donation on an annual basis to help support the many programs and services of the Lions of Illinois Foundation. With the annual contribution of \$25 (less than 7¢ per day) through the Sustaining Supporter program, an individual is able to demonstrate a commitment to the Lions of Illinois Foundation and to its vision of creating a permanent vehicle for the delivery of programs and services to the visually and hearing impaired. The initial \$25 contribution entitles the Sustaining Supporter to receive a pin. Upon renewal, the Sustaining Supporter receives a numbered tab that may be attached to the pin.

How do I become a supporter? Contribute \$25 to the Lions of Illinois Endowment Trust and attach the form below. Renewals are \$25 each. (Or, contribute \$25 to give someone a Sustaining Supporter as a gift or award/recognition.)

Yes! Sustaining Supporter contributions are completely convertible to Foundation Fellows. For more information, contact the Lions of Illinois Endowment Trust.

100% Sustaining Supporter Club: When a club donates \$25 per member in one club check payment to the Lions of Illinois Endowment Trust, the club will then be recognized as a 100% Sustaining Supporter Club. Each club member will be recognized as a Sustaining Supporter. Please send a list of club members, with address and phone with your form and check.
