LIONS OF ILLINOIS FOUNDATION LIABILITY WAIVER AND RELEASE BASEBALL EVENT

As a condition for attending the Event, all campers (or their authorized parent or guardian), counselors, volunteers and PAs/VGs are required to read and sign this waiver and release.

- 1. I acknowledge the requirements and inherent risks associated with my travel to and from and attendance at the Event, which is affiliated with the Camp and the Lions of Illinois Foundation (the "Foundation"), and is scheduled to take place on <u>August 1, 2023</u> at Busch Stadium, located at 700 Clark Street, St. Louis, Missouri 63102, including the requirements, conditions and risks set forth in this liability waiver and release.
- 2. Specifically, I acknowledge my status as a camper (or authorized parent or guardian), counselor, volunteer or PA/VG who is freely attending the Event to support the mission of the Camp and Foundation, a charitable organization. I acknowledge that the Camp and Foundation do not provide any health, disability, or life insurance coverage for campers (or their authorized parent or guardian), counselors, volunteers or PAs/VGs, and I am expected and encouraged to have my own health insurance coverage, at a minimum, before attending the Event. The Camp and Foundation do not assume any responsibility for reimbursing me for any medical expenses or other losses incurred in connection with any injuries suffered while participating in any Camp activities, including attendance at the Event.
- 3. Additionally, I understand the risks—inherent or otherwise—associated with the Event and my voluntary attendance the same. I also represent that, as a camper (or authorized parent or guardian), counselor, volunteer or PA/VG, I (or my child/children, as applicable), I/we: (1) am/are physically fit and not suffering from any injury, illness, condition, impairment or disease that would preclude me (or my child, as applicable) from attending the Event in a manner that is safe for myself (and my child) and others; and (2) will comply with all written and oral rules, warnings, instructions and directions given by the Camp and/or Foundation.
- 4. I, on behalf of myself (and the child/children listed below, as applicable), as well as my/our agents, assigns and heirs, fully and unconditionally waive, release and forever discharge and hold harmless the Foundation, Lions International, the Camp [any other entity and/or the name of the contracting camp], and their respective officers, members, employees, agents, contractors, staff and volunteers, for any and all injuries, losses and damages arising out of or in any way related to the Camp and the Event, including but not limited to all claims, causes of action, judgments,

costs and expenses of any sort that may arise from my participation in such activities associated with the Camp and the Event.

I HAVE READ THIS CONSENT FORM AND I UNDERSTAND THAT IT IS A RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT. BY SIGNING THIS FORM, I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, AND I HAVE SIGNED THIS AGREEMENT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
